- DEADLINE:** All applications must be submitted by 14 February 2018.

- Please include an individual app for each clan if you will be representing multiple clans or organizations.
- CLAN SPACE:** Booth space is limited to a plot 15' x 20'. Multiple plots may be reserved. Come prepared for all types of weather. You must secure your booth in case of windy conditions. The plot will be 15' wide facing primary walk path, and the space will be 20' deep.
- ELECTRICITY:** Clans must list all electrical connections on application. Electrical arrangements must be made prior to your arrival. Last minute electrical changes will not be accepted. (ALL GENERATORS MUST BE APPROVED BY SEAHG)
- MERCHANDISE:** Clans are permitted to gift items for donations related to the clan only. All items being gifted for donations or displayed **MUST** be contained in the booth space purchased. No items, solicitation, or set-up shall take place outside the purchased booth space.
- WEATHER:** This is an outdoor event; be prepared for any type of weather. Tents, canopies and pop-ups must be secured to withstand the weather. There is no rain date as a contingency. The event will occur rain or shine, barring weather of a dangerous nature.
- REQUIREMENTS:** The clan will be responsible to be open during the entire festival. You cannot vacate early. Your booth must be neat, attractive and well-maintained. Signage with visible and clear information is required. You are responsible for setting up, maintaining, and removing your own booth, your merchandise (if applicable), and your trash.

RELEASE AND WAIVER OF LIABILITY for VENDORS

1. **Waiver and Release.** I hereby release and forever discharge and hold harmless **SEAHG** and its successors and assigns from any and all liability, claims, demands, and causes of action, of whatever kind of nature, either in law or equity, which may hereafter arise from my participation with **The Southeast Alabama Highland Games** and/or any project, activity, or event sponsored, managed, arranged, or promoted by, or otherwise affiliated or associated with **SEAHG**.

I understand and acknowledge that this Release discharges **SEAHG** from any liability or claim that I may have against **SEAHG**, with respect to any bodily or other injury, illness, death, or property damage that may result from my participation. I also understand that **SEAHG** does not assume any responsibility or obligation to provide financial assistance or other assistance, including, but not limited to, medical, health, or disability insurance, in the event of injury, illness, death, or property damage.

2. **Insurance.** I understand that **SEAHG** may elect to provide group accident or other liability insurance. Any coverage so provided will be governed by the policy language. Except to the extent that it may provide such insurance, **SEAHG** does not carry or maintain any health, medical, disability, damage, or other liability insurance coverage for the benefit of its vendors, and expressly disclaims any responsibility or obligation to do so. AS A VENDOR, I AM EXPECTED AND ENCOURAGED BY **SEAHG** TO MAINTAIN MEDICAL, HEALTH, AND ALL OTHER APPLICABLE INSURANCE COVERAGE FOR MY OWN BENEFIT.
